Contact Information

First and last name, date of birth when required for travel, email address, phone number, mailing or billing address.

Identity and Travel Documentation

Passport information, government ID if required for travel or booking, visa information where applicable.

Financial Information

Payment card details processed via secure third-party processors, billing address, transaction and payment history.

Profile and Preference Information

Travel preferences, golf handicap or playing preferences, marketing preferences, communication history with us.

Travel and Booking Information

Trip selections, rooming preferences, dietary requirements, mobility or accessibility needs, emergency contact information.

Information Collected Automatically

When you use our website or digital services, we may collect technical data such as IP address, device type, browser type, operating system, and usage data such as pages visited and time spent on site.

How We Use Your Data

To provide travel services, manage bookings, process payments, support operations, improve services, and send marketing communications where permitted.

Data Sharing

We may share data with travel partners such as golf courses, hotels, transportation providers, payment processors, IT providers, marketing platforms, and regulatory authorities when legally required.

International Data Transfers

Because travel services are global, your data may be transferred outside the United States. When this occurs, we use appropriate safeguards and industry-standard protections.

Data Security

We use commercially reasonable security measures to protect your personal data. However, no internet transmission is completely secure.

Data Retention

We keep personal data only as long as necessary to provide services, meet legal requirements, resolve disputes, and enforce agreements.
